Cloud hosting is where the web reporting is hosted by WJPS through their third party hosting provider. Our hosting provider is Redcentric Ltd who are a registed N3/HSCN provider. Therefore the server could access the N3/HSCN. This server would connect to you in house data server where input data would be held. There data we would store would relate to the web interface only, and provide a readonly pass throw to you server for room reporting data.
